Opening Session: Achieving Ambisyon Natin 2040 Through Evidence

Secretary Ernesto M. Pernia, National Economic and Development Authority

Dr. Ernesto M. Pernia is the current Secretary of Socioeconomic Planning and Director-General of the National Economic and Development Authority. Besides being Professor Emeritus of Economics at the University of the Philippines and a former fellow of the Institute for Development and Econometric Analysis, he has worked on projects on investment climate and productivity, economic growth and poverty reduction, education and health, human resource development, and regional economic cooperation.

Secretary Benjamin E. Diokno, Department of Budget and Management

Dr. Benjamin E. Diokno is the current Secretary of the Department of Budget and Management. He also holds a Master of Arts in Political Economy from the Johns Hopkins University and a Ph.D. in Economics from Syracuse University in New York. Prior to serving as Budget Secretary, Dr. Diokno has worked as an adviser and consultant to multilateral agencies such as the World Bank, the Asian Development Bank, European Commission, and USAID. In his third tour of duty, he intends—among others—to get the Budget Reform Bill passed to ensure systems and other enabling mechanisms are in place to make every government program is worth every peso spent.

Panel Discussion: Integrating Evaluation in Government Institutions and Policies

Director Tess Gregorio, Department of Budget and Management

Director Tess Gregorio is the Director of Bureau-Fof the Department of Budget and Management, which, **among others, undertakes the department's monitoring and evaluation function**. The increasing demand for fiscal transparency and accountability, and the growing need to integrate performance information in the budget process for a more effective delivery of public goods and services paved the way for putting up mechanisms for M&E within the Department.

Ms. Celia M. Reyes, Philippine Institute for Development Studies

Dr. Celia Reyes currently the President of the Philippine Institute of Development Studies and is the first female member to hold the position. As a poverty research expert, she specializes in the use of econometrics to evaluate social protection programs. Dr. Reyes is also the network leader of the Community-Based Monitoring System (CBMS), a local poverty monitoring tool she developed under the Micro-Impacts of Macroeconomic Adjustment Policies project. She holds a PhD in Economics from the University of Pennsylvania.

Dir. Rhodora Alday, Department of Social Welfare and Development

As Director-IV of the Policy Development and Planning Bureau of the Department of Social Welfare and Development, Ms. Rhodora Alday oversees the conduct of research and evaluation studies on the **Department's** programs and services. Recent evaluations she supervised include the Rapid Evaluation of Educational Assistance to Beneficiaries of Assistance to Individuals in Crisis Situations (AICS) and the ongoing study on the DSWD Residential Care Facilities where she serves as the Evaluation TeamLead. She is a social work graduate with a development studies masters from the International Institute of Social Studies (ISS) in The Hague, Netherland.

Assistant Secretary Jonathan L. Uy, NEDA

She has been awarded, among others, with the American **Evaluation Association's Myrdal Awa**rd for Evaluation Practice and the **Australasian Evaluation Society's** Caulley-Tulloch Prize for Pioneering Literature in Evaluation.

Prof. Greet Peersman, BetterEvaluation

Professor Greet Peersman is the Deputy Director of BetterEvaluation. She has served as the Senior Evaluation Advisor to the Joint United Nations Programme on HIV/AIDS (UNAIDS), and the Deputy Director for M&E of the Global AIDS Program at the US Centers for Disease and Prevention. She is also an Associate Professor at the Australia New Zealand School of Governance. Her three decades of expertise in evaluation and evidence-based policies entail working with government departments, international and donor agencies across Africa, Asia, and Latin and South America to strengthen M&E systems as their tool for better programming for health and international development.

Mr. Martin Porter, UNICEF

Mr. Martin Porter has been the Chief of Planning, Monitoring & Evaluation in UNICEF Philippines since June 2015. As such, he has lent his expertise in PM&E by providing government agencies with technical assistance on strengthening and developing their capacity for results-based monitoring and evaluation. He has previously served in UNICEF headquarters where he worked in humanitarian planning and results-based monitoring, and was deployed to the Philippines for 3 months from 2013-2014 as part of the Typhoon Yolanda response.

Ms. Mai Valera-Co, UNDP

Ms. Mai Valera-Co is presently the Monitoring and Evaluation Officer of UNDP. Her professional experience with UNDP, and formerly with government agencies, NGOs, and academic institutions, has been focused on supporting the design and implementation of policies, programs, and projects through M&E research and capacity building. She holds an MSc in Public Health (Health Economics) from the London School of Hygiene and Tropical Medicine under a UK Chevening Scholarship, an MA in Development Economics from the University of the Philippines.

Mr. Jose Roi Avena, UNFPA

Mr. Jose Roi Avena is the M&E Adviser of the United Nations Population Fund. Rep. Joey Salceda, House of Representatives

Rep. Joey Salceda is the congressman of the Second Congressional District of Albay. He is currently Vice Chairperson of four House Committees, including Economic Affairs and Local Government. He pioneered the establishment of the Climate Change Academy, the first in the country. For his efforts on disasterrisk management and climate change adaptation, Rep. Salceda was acknowledged as the First Senior Global Champion on Disaster Risk Reduction and Climate Change Adaptation by the United Nations International Strategy for Disaster Reduction (UN-ISDR). He has also been a member of the Board of the Green Climate Fund, the finance arm of the United Nations Framework on Climate Change Convention.

Mr. Ronald Golding, Senate of the Philippines
